

## Match-Day Roster Rules

- The assigned coach's name of record must be printed on the Match Day Roster.
- If the assigned coach is not available, the attending coach's name must be written on each Match Day Roster prior to kick off.
- All Club Staff (maximum of 4), supporting the coach, must have a valid US Club ID card (from their Club) either printed or virtual on them.
- Coach must pass background check
- Video Policy
- Video cannot determine outcome of match





## **Rule 520 Review**

- Only Club Directors or designated Club staff are allowed to email/file Violation Reports, Referee protests, and/or raise concerns about sideline behavior to the League office.
- Correspondence from any other party (parent, coach, etc.) will not be accepted
- We ask DOC, or equivalent, to filter complaint and determine whether it needs to be reported to the league.
- Club officials shall follow Violation reporting process.
- League does not overturn referee decisions between the lines.





## WPL Discipline Report

- Persistent Theme of Violent Conducts and Offensive, Insulting or Abusive Language.
- Some of these resulted in player expulsion from the Season/ Year.
- Weekly send-offs were averaging 10 per week which is higher than last season.
- Coaches need to improve Game Day Management and remove the player(s) from game to deescalate the situation.
- More education for Coaches on how to manage Game Day scenarios.





## Rule 530 Review

**Match-Suspension Procedures:** 

•Club Officials may submit evidence related misconducts directly to discipline@wpl-soccer.com prior to Wednesday of the week following the Match.

•League will send Charge Email for the expulsion(s) to DOC / Club Official by Thursday of the week following the Match.

•Player is not cleared until the signed Match Report by the Referee is uploaded into GotSport.







## **Referee** Issues

- Coach
  - Verbal dissent and irresponsible behavior
  - Responding to Parent behavior
- Players
  - Racial slurs
  - Verbal dissent and persistent arguing
- Parents
  - Verbal Abuse
  - Irresponsible behavior towards a minor •







## Game-Day Issues: Most Common

- Rosters/Cards
  - Write-ins on the roster
  - Missing player card
- Players
  - Not enough players to start
  - Jersey numbers
- Rule variances
  - U12 and below





## **Referee Numbers**

WA Registered Referees 2023 - 4,683 2022 - 3,921 2021 - 3,213

> Referee Retention 2023 - 53% 2022 - 56% 2021 - 78%

## US Club Racist & Bigoted Language Protocols

- In advance of NPL and National Cup Final we are looking to implement the following protocols related to racist and bigoted language.
- The goal would be to trial these and then potentially role them out as SOP for the fall season.
- If a racial slur is used and heard by referee, a player, coach, or parent, and corroborated during the match, then that person will be red carded, or parent/ spectator will be asked to leave.
- The the coach of the offending supporter's team could receive a yellow card.
- The player will be banned automatically from the rest of the event, and in the case of a player or coach, additional game suspensions depending how many matches were missed at this event up to 5 Games.
- If a racial slur is alleged during the match, and not corroborated by referee, the player(s) should notify their coach and/or referee, who will then stop the match to allow both coaching staffs to address their players.
- Teams will not return to the field unless BOTH coaches/teams are comfortable to return.
